**RE: SET PUBLIC HEARING FOR DOVER RIDGE WATER AND SEWER RATES**

**WHEREAS**, the Town Board of the Town of Beekman is responsible for the operation and management of the Dover Ridge Water and Sewer Districts; and

**WHEREAS**, Article 14-F of the General Municipal Law authorizes the local legislative body to set water and sewer districts user rates on behalf of the Water and Sewer Districts by resolution after a public hearing; and

**WHEREAS**, the Town Board is desirous in setting water and sewer user rates to reflect the actual cost of operating the water and sewer districts; and

**WHEREAS**, the 2020 Budget is the basis of calculation of new user rates for Dover Ridge Water and Sewer Districts; now therefore be it

**RESOLUTION NO. 11:13:2019 – 4**  
**RE: WAIVE TOWN FEE FOR MARRIAGE LICENSE OF ACTIVE U.S. MILITARY**

**WHEREAS**, the current license fee for a marriage license charged by the Town Clerk is \$40.00 with \$17.50 representing the Town's share of that fee and \$22.50 representing the State portion; and
